WHITEHEAD, 21 November 1821, conveyed all interest in estate of BURCHER WHITEHEAD, his father, in Deed of Trust; defaulted, to secure THOMAS ALDRIDGE, advertisement in Lynchburg paper and sold at ACH, 29 August 1822 (sic) and ALDRIDGE bought at \$51.00 as agent of JONATHAN WHITEHEAD.
