HILL, late of Virginia, but now of Alabama, debts due me; judgement recovered and paid to DAVID S. MOORE as bondsman for HILL--to SAMUEL SIMMONS, 18 July 1832--from 31 July 1820. One suit pending in Lynchburg Chancy--SIMMONS versus HILL; interest of HILL in estate of JAMES WILLS (sic), Nelson; interest in his mother's estate in Bedford.
