PHILIP THURMOND -- Book 4, Page 141 -- September 5, 1803; December 19, 1803. Witnesses: P. GOOCH, PHILIP LOCKHART, MATT. TUCKER. Proved on probate by GOOCH and January 16, 1804 by LOCKHART. JUDITH THURMOND qualified; bondsmen: WM. SLEDD, WM. THURMOND. Of Lexington Parish; all of my children; daughter, JUDITH; daughter, SALLY WARE; son, WM.; daughter, ELIZ. RUCKER; daughter, MARY M. MC CABE; son, PHILIP; my unfortunate children: FRANKY and THOS. When JUDITH marries; wife to administrate along with CHAS TUCKER and son, PHILIP. Note: JUDITH was a TUCKER and some of family went to Georgia--deed data.

Another was in Washington County, Kentucky and on and on they are found.

WM. THURMOND -- Book 5, Page 70 -- May 20, 1811; WM. has been sentenced to two years in penitentiary. JNO. TUCKER and ELIAS WILLS are made trustees. I think that he killed a slave.

MARTHA JANE TINDALL -- Book 6, Page 722 -- Guardians B TINDALL and WM. PAMPLIN, February 19, 1827, for LEWIS guardian of MARTHA JANE LEWIS TINDALL, orphan of LEWIS
